Call for the assignment of 8 Scholarships for the master degree in Data Science and Scientific Computing – 2020 edition

The University of Trieste has an agreement with some national and international companies (BeanTech, Cybertec srl, AcegasApsAmga SpA, BeanTech, Plusolutions, 3 Technology, Generali SpA) to fund 8 scholarships a total of 22,400 Euros for 8 students admitted to the Master Degree in Data Science and Scientific Computing, 2 of them reserved for female students.

**Article 1 - Purposes** 

Scholarships are intended for the training of future high-profile graduates in Data Science and Scientific Computing.

The call is addressed to students coming from Units, Italian or foreign Universities who have applied for admission to the LM course in Data Science and Scientific Computing and that passed the selection procedures for access as for in art. 2.

Each student getting the scholarship will receive 2,800 Euros (gross of taxation), beneficial to fund the first year of the Master's Degree. The second year the student will be involved in an internship of at least 6 ETCS with the company that financed the scholarship.

**Article 2 - Requirements for Participation** 

Applications for participation to the selection may be submitted by students already enrolled to the Master's Degree in Data Science and Scientific Computing, following the selection procedures that took place in June and September 2019 at the Department of Mathematics and Geosciences.

Article 3 - Terms and conditions for submitting the application

The application for participation to the selection (All.1) must be submitted by **12th June 2020** only via email, in PDF format, to the address <u>dirittoallostudio@amm.units.it</u> and in cc to <u>dssc@units.it</u>. Applications submitted after this date will not be accepted.

The candidate must attach to the application:

a. photocopy front and back of a valid identity document;

b. accompanying motivation letter to apply to the selection;

c. curriculum vitae et studiorum in European format;

d. self-certification of the degree mark obtained (for graduate students only) and the passed courses, together with the relative marks.

## Article 4 - Selection of candidates and subsequent interviews

The applications received will be evaluated by a Selection Board appointed by the Rector, formed by professors of the Data Science and Scientific Computing Council.

The selection procedure will take place in two phases:

a) FIRST PHASE in which the documents submitted will be evaluated, resulting in a list of candidates admitted to the interview with the companies, applying the same percentage of score for each requested title;

b) SECOND PHASE in which individual interviews will be held for the candidates selected in the first phase.

The list of candidates admitted to the interview and the date of the interviews will be published online on <a href="http://web.units.it/premi-studio">http://web.units.it/premi-studio</a>. Interviews will be held in teleconference format by the sponsoring companies, with the participation of professors members of the committee.

Should the company being unable to be present at the interviews, the interview will be held by the the selection committee.

Candidates failing to be present at the interview will be excluded from the selection.

If necessary, for clarification purposes, the office may ask the candidates for an integration in the documentation, as deemed appropriate.

At the end of the evaluation procedure, a list of students awarded the scholarship will be published.

The results of the selection will be made public at <a href="http://web.units.it/premi-studio">http://web.units.it/premi-studio</a>, as well as on the website of the Master Program, within 5 working days from the date of the last interview.

Within 5 days of the date of publication, scholarship winners will have to confirm their acceptance by sending an e-mail to <a href="mailto:dirittoallostudio@amm.units.it">dirittoallostudio@amm.units.it</a> and in cc to dssc@units.it.

## Article 5 – scholarship payment

The scholarship covers the enrollment in the first year of the Master's Degree in Data Science and Scientific Computing. The student is invited to participate in the activities offered by the financing company that will be articulated in both years of Master's Degree, culminating in an internship of at

least 6 ECTS (or other agreed solutions between the coordinator and companies).

The granting of scholarships is conditional upon the actual undertaking of the internship at the company, under penalty of forfeiture of the scholarship. The student who has already received the scholarship and does not complete the planned internship, must return the scholarship received. The Administration reserves the right to verify the veracity of the statements made during the self-

certification; if false statements or false data are found, the grant of the scholarship will be revoked.

Article 6 - Incompatibility

The scholarships of this call are incompatible with the scholarships issued by the Regional Agency for the Right to Higher Studies of Friuli Venezia Giulia (ARDISS) if they exceed the limits indicated in art. 23 of the Ardiss Regulation for the ay. 2019/2020 or those indicated by the relative regulations of the regional agencies of other Regions. They are also incompatible with scholarships from SISSA (International School of Advanced Studies) and from the Collegio Luciano Fonda.

Article 7 - Information on taxation

Based on Art. 50 of D.P.R. 22/12/1986, n. 917, sums received as scholarships, allowances, awards or subsidies paid for study purposes are similar to a salary, hence subject to italian taxation (Irpef and Irap (at 8.5%)

Article 8 - Processing of data (Privacy Policy UE 2016/679)

The personal data provided by candidates in the application for the selection will be collected and processed for the purpose of managing the selection procedure only. The provision of data is mandatory and necessary to enable the selection to be carried out correctly. Incomplete data will result in exclusion from the selection itself. The data may be communicated to other university administration offices for the planned checks.

At any time, the persons concerned may exercise their rights under *Privacy Policy UE 2016/679* (Personal Data Protection Code).

The holder of the data processing is the University of Trieste, piazzale Europa 1, Trieste.
